Eligibility and Merit Criterion for Admission to B. Tech. (ECE/ECM/ME/CIVIL):

Pre-requisite: Passed out students of 10+2 or equivalent (with Physics, Chemistry, Mathematics and English subjects), having aggregate of 50% marks for General Category and 45% marks for SC/ST & Disabled Persons Category, will be admitted on the basis of Merit of Aggregate Marks obtained by them in 10+2.

Seat Allocation & Preparation of Waiting List:

- 1. After the last date of Fee Deposition (i.e. August 11, 2020) by the applicants appearing in the Merit List (Allotment-1) of counseling Round #1, the branch Up-gradation of the Fee confirmed applicants of Round #1 will be done against the Vacant / Left over Seats. The seats remaining still vacant after Branch Up-gradation in various courses will be offered to the applicants registering on and after August 7, 2020 (i.e. during counseling Round #2), according to the merit of aggregate marks of 10+2. According to the number of applications received, the day of allotment will be decided and published on our Admission Portal (www.pupadmissions.ac.in) after August 12, 2020. The applicants are advised to regularly visit the website for update in this regard.
- 2. After counseling Round #2, the vacant seats, if any, will be filled on daily basis, as per the merit of applicants applying on that day. In case of no vacancy in **the** respective branches, the applicants will be put in the waiting list according to the merit of their marks in 10+2 and the day of receiving of their application. As and when the vacancy is created in any branch, due to surrender of seat, the seats will be first offered to the already admitted candidates, who are eligible for branch up-gradation, and the seats remaining vacant after up-gradation process will be then allocated to the waitlisted candidate(s) of the respective branches, according to their position in the Waiting list.

Note: The applicants, after depositing the requisite Application Form Fee, must fill all the necessary fields in the Application Form and submit their form. Subsequently, the applicants must also ensure to upload the necessary documents / Certificates, viz. 10th DMC, 10+2 DMC, Reserved Category Certificate (if Applicable), Income certificate (for SC candidate only, having family income less than 2.5 Lakhs per annum) etc., on the "Student Login" button available at the Link http://counselling.pupadmissions.ac.in/main.aspx on our Website: www.pupadmissions.ac.in, by entering their User ID and Password. The online admission done will be entirely provisional, subject to the physical verification of the documents submitted by the candidates. Besides, the Tie breaker rules, as specified earlier, will remain applicable as such, if needed.
